

Crop Protection Investment

THE SHARE OF CROP PROTECTION R&D INVESTMENT IN THE EUROPEAN MARKET FELL FROM: 33.3% IN THE 1980s TO 7.7% BY 2005-14 THE NUMBER OF NEW CROP PROTECTION PRODUCTS COMING TO THE MARKET PER YEAR HAS DROPPED BY 70%



Crop Protection Legislation

- 1991 Directive, central actives registration
 - simplification, more clarity,
 - assessed risk: classically, 'the poison is in the dose'
 - reduced registrations and innovation
- 2009 <u>Regulation</u> –very ambitious
 - implementation still being worked out into 2015...
 - assesses hazard: precautionary, 'don't even go there'
 - brings much uncertainty
- How's it working?
 - Increasing use of EU 5 year derogations and national emergency use approvals




Crop Protection Registrations
